Merribel Ayres: Director Profile



Merribel Ayres, an American businesswoman co-located in Milan (Italy) and Washington (DC), has 35 years-experience in the energy and environmental sectors with both US and European firms. As a corporate Director, she has played a leadership role on environmental, social and governance issues (ESG), where she has been recognized for successful impacts on profitability and risk management.

Ms. Ayres has been a central player in the international energy transition. Her in-depth background with leading energy businesses (their investors and stakeholders) enables her to provide a critical perspective for Boards, with an ESG focus. She is recognized for her expertise in Climate, Carbon mitigation and related energy system strategies.

Her Board experience includes a Director role with CMS Energy (NYSE: CMS), a Michigan-based electric and gas utility. At the conclusion for her 9-years of service, she was recognized by her fellow directors for significant contributions to the company's forward strategy, with an emphasis on clean energy, environmental and sustainability matters, as well as corporate governance. Her committee assignments during her tenure at CMS included: Governance and Corporate Responsibility, Finance, Audit and Compensation.

She is currently a Board Member of the United States Energy Association (USEA). She also served as a member of the Advisory Council of the National Renewable Energy Laboratory and as a Director at Alliance Resources, LP.

In Milan, she serves on the Steering Committee of Chapter Zero Italy, the Climate Governance Initiative (CGI) of the World Economic Forum, which is focused on Board of Director engagement on climate impacts and strategies for reduction of greenhouse gases.

A strong communicator, Ms. Ayres is experienced in public speaking. Prior to the COVID lockdown, she chaired the North American Session at the World Energy Congress (Triennial event) in Abu Dhabi. She recently chaired a webinar on ESG topics (<u>https://www.ourenergypolicy.org/esg-and-energy/</u>). She also gave an on-line tutorial for Forum 2100 (<u>http://www.forum2100.org</u>) on the political realities of developing Climate Policies in the US Congress.

As founder and principal of Lighthouse Consulting Group, an advisory firm established in 1996 serving both US and European clients, Ms. Ayres has provided management services to CEOs and senior executive teams. Under her direction, Lighthouse was chosen to lead the prestigious US Climate Action Partnership (a coalition of 25 major companies and five national environmental organizations).

As an Advisor and Director, she has helped major companies to:

- Identify strategic partners, anticipate the future of their sector and set (reset) business objectives accordingly.
- Navigate and facilitate relationships with key internal and external stakeholders (Business, Gov. & NGO).
- Assess and address corporate strategy impacts of investor demands and related policy initiatives.
- Design and deploy messages, narratives and communications campaigns.
- Manage succession planning in the C-suite, including Board composition and related dynamics.
